MDes or MEng Programmes are over four years with the possibility of doing an industry Enhancement year. This is reflected within the exit titles associated with the four-year courses, either Sandwich BA/BEng (Hons) qualification or an integrated Masters course with an MDes/MEng qualification. The integrated Masters route is designed for high achieving students to continue their studies and to develop advanced technical skills; as such, achievement attained during level 2 is used to determine suitability for progression.
